****T4 Eligible with No Outstanding Eligibility Items:****

Dear Student,

Great news! We reviewed your 2019-2020 federal financial aid eligibility and determined there are no outstanding items to resolve. South University is preparing to issue your Higher Education Emergency Relief Fund (HEERF) financial aid grant, as outlined in the CARES Act.

Based on your 2019-2020 FAFSA and resulting Institutional Student Information Report (ISIR), your Expected Family Contribution (EFC) is XXXXXX. Based on your EFC and your demonstrated eligibility to participate in the Title IV programs, you are eligible to receive \$XXXXXX in emergency financial aid funds. Dear Student,

We reviewed your 2019-2020 federal financial aid eligibility and determined there are outstanding items that must be resolved prior to our issuance of your Higher Education Emergency Relief Fund (HEERF) financial aid grant, as outlined in the CARES Act. Please contact the financial aid office to review your outstanding items, such as: completing verification or resolving a C Code or conflicting information. Students will have 90 calendar days from this notice to resolve outstanding items so that we may make a final determination of your eligibility.

South University scheduled the award based on your 2019-2020 FAFSA and resulting Institutional Student Information Report (ISIR) with your Expected Family Contribution (EFC) on the most recent ISIR we have on file. Your EFC is XXXXXX. As South University awarded all funds received to the student, your award was established based on your EFC on file. Once you have submitted the necessary information the financial aid staff will review and determine if there is a change in your EFC. Assuming your EFC does not change as a result of the outstanding information, you may be eligible to receive \$XXXXXX in emergency financial aid funds.
